## Additional Resource Consent Required Associated with Resource Consent Application Nos RM210785 & RM210786 – 54 Green Lane, Motueka – Section 91 RMA, and response to Further Information Request per Section 92 RMA

I refer to your applications for resource consent described above. It has been determined, pursuant to Section 91 of the Resource Management Act 1991 ("the Act"), that a further application for resource consent is required as follows:

## 1 **Diversion of Floodwaters**

Brigid Greaney, Council's Senior Consent Planner - Natural Resources, has reviewed the further information supplied and advises that the proposed bund will require a resource consent as it does not comply with Tasman Resource Management Plan Rules 18.5.2.1(v), and is a Restricted Discretionary activity under Rule 18.5.2.5.

It is noted that the report provided by Envirolink Ltd finds that "with the proposed noncontinuous bund, changes in flow depths are considerably reduced' compared with the continuous bund. However with amendments to the design to mitigate the effects of the continuous bund, changes in flow depths are not completely removed, as the report also indicates that modelled flow depth on an adjacent property is increased.

Based on this, it is considered that the proposed earthworks to form the bund (with gaps) 'may result in the damming or diversion of floodwaters' (Rule 18.5.2.1(v)), and therefore consent is required.

Council's Senior Consent Planner – Natural Resources advises that no additional information is required regarding the above consent application, except that you confirm that you wish to apply for the above consent.

No deposit is required at this time for this additional consent application.
