BAY BLAZES ITS OWN TRAIL

Golden Bay is getting on its bike and making an ambitious bid to hook up with the national cycleway project.

A shared walk/cycle path is planned to follow the Takaka River from the Waitapu Bridge, through Takaka township, out to Paynes Ford, the Uruwhenua Bridge and on to the foot of Takaka Hill. Tasman District Councillor Stuart Borlase says from there the track would cut across to the Cobb Valley heading towards Mt Arthur. The Graham Valley is then within reach.

Regional plans for a cycleway from Motueka to Kawatiri will eventually give the Golden Bay trail its link to the national cycle path, which is proposed to follow the old railway corridor from Nelson south.

Cr Borlase says the Bay initiative got off the ground in 2005 with the formation of a committee. He first thought the river route would mostly use the Queens Chain, but discovered that in fact the Crown owns very little of the land. Negotiations with farmers for access have been timeconsumina.

Cr Borlase says the success of the Otago Rail Trail has been a wake-up call

for farmers down south, many of whom are now enthusiastic supporters. Some even offer accommodation to cycle tourists.

He can sense a similar groundswell in Golden Bay, even though earthworks have only begun this year, with a half kilometre of track formed so far of the planned 25 kilometres.

"There's no reason Golden Bay can't have a cycle trail as good as Otago."

Volunteers gather every Saturday – and sometimes Sunday – to work on the track, putting in boxing, a fabric base and a clay-gravel topcoat that sets hard in the sun. The finished section of path is 1.5m wide and meanders around tree trunks and through bush. It already offers youngsters a safer route part-way to school.

Cr Borlase says the trail has received no Government money, relying on charity grants, and is very much a ground-up effort.

"That's the way Golden Bay operates."

More and more members of the public are fronting up on Saturdays to pitch in, and community service workers are also involved, he says.

Cr Borlase confesses he is more of a walker himself, but "biking is a really good thing". Next autumn he plans to be in Central Otago with friends pedalling the trail that has spread its influence nationwide.

MENTORING SCHEME TAKES NATIONAL HONOUR

Tasman businesses benefit from the best advice in the country. Endorsements from local firms that use the Nelson Tasman Business Trust's one-to-one mentoring have earned it the Agency of the Year award.

Local trust manager Sarah Holmes and the team beat 13 other schemes nationwide that are part of the Business Mentors NZ network.

Tasman District Council helps to fund the Trust.

The inaugural award, set up to recognise the efforts of agencies that assist business people, was judged on feedback from clients across three areas:

- · The promptness of the agent's response
- · Level of follow-up support
- · Overall satisfaction of service

Sarah says the team were thrilled to win the award, which she sees as testament to the quality of the 86 volunteer mentors involved in the Nelson-Tasman scheme, which has assisted 142 businesses in the last year.

"We have a skilled base of mentors working with clients across a range of businesses, from hazelnut growers and jewellers, through to photographers, a chocolate maker and a mountainbiking venture."

The Trust matches mentors to businesses, which then benefit from two years of mentoring support – all for the cost of a \$112.50 registration fee.



"A business mentor is someone who can provide independent objectivity," says Sarah. "They can share skills that the business owner might be missing, brainstorm together and provide advice and feedback on a whole range of different areas."

Operating locally since 1989, the Trust also receives funding from the Nelson City Council and the Canterbury Community Trust.

TARGETED TOURISM RATE PROPOSED CHANGES EXPLAINED

As part of the 2010/11 Draft Annual Plan the Tasman District Council is proposing a number of changes to the targeted rate on businesses benefiting directly from tourism.

The targeted tourism rate is levied by Council to assist with the funding of Nelson Tasman Tourism and is funded by those who will most directly benefit from the agency's activities. It is additional to a separate direct contribution from the Council paid out of the general rate.

In this year's Draft Annual Plan the Council is considering three amendments to the targeted rate, the first being a \$4.29 annual increase from \$137.21(GST incl) to \$141.50 (GST incl) to account for inflation.

Another proposed amendment is the extension of the coverage of the targeted rate to include rented holiday homes. Council feels that holiday homes that are rented out for periods of less than 90 days within the region, much like motels and B&Bs, have benefited from the marketing work of Nelson Tasman Tourism to attract people to the region.

Already within the targeted rate coverage are retail outlets within the District, but the Council's rating system had not taken into account properties that house more than one retail outlet, i.e. shopping centres. This means that these retail outlets are not subject to the current targeted rate while deriving the same benefit standalone retail outlets are. As a result, full coverage of retail outlets for the targeted rate only is being considered as a result.

In addition to these changes the Council is also seeking public views on a further request by Nelson Tasman Tourism to increase the amount paid to them by \$50,000. This is a one-off request for additional money to enable the agency to access a dollar for dollar subsidy from the Government for marketing specifically to the Australian market. If this request gains industry support the targeted rate will increase to \$217.13 (GST incl).

As part of the Annual Plan consultation process, Council has written to most ratepayers affected by the amendments to fully inform them of the changes. Council is seeking people's views through submissions on the Draft Annual Plan.

SPOTTING A NEW TREND

The newly revamped carpark at the Takaka Library is about to grow spots – green spots.

With carparks in general being designed to squeeze in the maximum number of vehicles, a new approach is being used around the world to encourage better driver behaviour when sharing spaces with pedestrians.

The spots are intended to break down the harsh expanse of black surfacing and encourage drivers to treat the area with more caution. Steve Elkington, Council's Transportation Roading Engineer, says the concept is inexpensive – plus it's a way of adding a little light relief into public places with safety in mind.

"There was some concern for pedestrians walking through the carpark."

Takaka will also knock the spots off the rest



of the country since this is believed to be the first use of the device in New Zealand.

NATIVE FISH GET A LEG-UP

One more wall has fallen in the campaign to free up Tasman waterways for native fish.

The large weir in the Moutere Ditch near Old House Road was deeply undercut, making it impossible for smelt, inanga and banded kokopu to venture upstream. Inanga make up the bulk of the whitebait catch.

Tasman District Council environmental resource scientist Trevor James is on a mission to even up the odds for such native fish species. Over the past five years 16 of the top 50 obstructions have been circumvented, giving fish access to streams in an area of 4200ha. The bulk of that has been in Old House Road, but a high-quality aquatic habitat has also been opened up again at Wainui Bay in Golden Bay, plus Onekaka and the Aorere Valley.

The Moutere Ditch weir, for instance, involved building a substantial ramp of rock and concrete. Trevor "borrowed" a group of youths on a Government work scheme at

Jim Thawley's orchard in Mapua. They had the concrete poured and rocks positioned in a day. Because a lot of inanga habitat is available upstream on this waterway and inanga have the least ability to swim, the weir "ladder" features small pools for them to hop between.

Over-hanging culverts make up 70 percent of all barriers. For most sites the maxim "fish are good climbers and lousy jumpers" applies, so a vertical face is the difference between making it upstream or not for many species.

With a budget of just \$8000 a year for the work on culverts under Council roads, Trevor makes headway on about four or five a year. This summer he also helped a number of private landowners to fix such barriers.

"We are always looking for innovative and low-cost solutions and, with the help of summer-student Ned Wells, we cobbled together a fish climbing ramp using an old conveyor belt – donated by Nelson Pine Industries – bolted to the culvert pipe outlet. The back of the belt has a ribbed surface ideal for climbers such as kokopu and koaro."

Overall, the task of freeing up Tasman waterways is daunting. About 1150 structures have been assessed, and 30 percent, or 349, were significant barriers. Under the Tasman Resource Management Plan, every structure must provide a pathway for fish where significant populations could exist upstream. Resource consent is not required for culverts in smaller waterways.

With the Moutere Ditch weir ticked off his "hit list" – and the whitebait fritters downstream just that little bit meatier – Trevor is moving on to the next blockage.

CORRECTION – TASMAN BAYS HERITAGE TRUST COMMENT IN DRAFT ANNUAL PLAN

The Council's Draft Annual Plan stated "The Tasman Bays Heritage Trust has asked the Council to modify one of the leased storage bays to make it suitable for storage of high value taonga.

The cost of the work is estimated at \$250,000. Subject to an agreement with the Trust, Council is proposing to undertake

the work, which will mean an increase of \$18,000 on the Museum rate to cover the loan servicing costs for the work".

While there had been informal discussions on storage issues between the Trust and Council, the Trust had not formally asked the Council to undertake the work.

The Trust has advised that storage and

care of the collection is to be examined in a feasibility study in 2010/2011, therefore, no capital expenditure has been planned in the next twelve months.

Council is awaiting further advice from the Trust and will make the necessary amendments prior to finalising the Annual Plan in June 2010.

With the abundance of fresh local fruit and vegetables in our shops and supermarkets at the moment there is no better time to learn the art of bottling, pickling and preserving to make sure your stocks remain high all winter round.

Rural Women NZ will also be having a display in Richmond Mall on Tuesday 20 April 2010 with members present to give advice and ideas on freezing and preserving fresh produce. Eligible businesses can download posters and registration forms from the website www.ecofestnelsontasman.co.nz and will also be able to share information about their products on the Ecofest Nelson Tasman Facebook group set up to support the event.

The Eco Challenge is being sponsored this year by FreshChoice Richmond, FreshChoice Nelson City, Bunnings and NZCU South, and there are Tasman and Nelson prizes to be won. The winners will each receive vouchers totalling over \$750.

Ecofest organiser Jo Reilly says the two local FreshChoice supermarkets are the ideal sponsors for the Eco Challenge, with both being owned by local people and with a strong focus on supporting local suppliers.

"FreshChoice Nelson City launched a buy local strategy in 2006, and highlights products grown or produced within a 200km radius by its <200k yellow logo. 

PEST OF THE MONTH

REED SWEET GRASS (GLYCERIA MAXIMA)

Glyceria is a tall robust perennial grass with lush, light green leaves.

Growing to over two metres tall, it is a particularly aggressive and troublesome plant along aquatic margins and damp pastoral zones where it is capable of forming large dense infestations under favourable conditions that smother other vegetation.

It forms a sprawling mat of rhizomes (underground stems) that can comprise 40-50% of the plants total biomass. In spring and summer, these rhizomes produce vast numbers of shoots that quickly expand the plants size. Growth slows in autumn and stops with the arrival of cool temperatures and frosts.

Glyceria can produce vast numbers of seeds, the majority of which are able to germinate immediately, while others can remain dormant for several years. In dense stands, reproduction seems to be entirely by vegetative means.

Its rate of spread along waterways is accelerated by the movement of farm machinery, vehicles and livestock carrying mud containing seeds or fragments of stems or rhizomes.

A native of Europe and Asia, it was introduced to other countries to provide animal forage in seasonally wet pastures but has since been implicated in cyanide poisoning of stock. It is currently found in the Waikato, Otago, and the Hauraki Plains and is considered a wetland transformer weed of conservation concern because of its impact on wetlands.



Known infestations in our region are largely limited to the Upper Buller and Murchison catchments, along with one site in Golden Bay.



Community Development Fund

The first round of applications for the Tasman District Council Community Development Fund were considered by the Grants and Community Facilities Rates Subcommittee on 31 March 2010. The Fund's aim is to enable the Tasman District's smaller communities to apply for funding to make plans, provide activities, run events or services to enhance their town or to attract visitors. The following projects were successful:

Mapua Boat Club Inc

Towards display boards and the reproduction of historic photographs of the area.

Allocation \$3,000

Mapua & Districts Business Association

Development and design of interpretative signage that would be used throughout the Ruby Bay Coast area.

Allocation \$3,500

SPARC Rural Travel Fund

The next round of the SPARC Rural Travel Fund closes on 30 April 2010. It is designed to help subsidise rural travel for junior teams, and is targeted at young people aged between 5-19 years. Autumn is a great time to get out on your bike whether for a leisurely ride to the local park or to a café. However if mountain biking is your thing, the Kaiteriteri Mountain Bike Park is worth checking out.

The track network is being created in a staged process. The first stage, completed in 2009, comprises a series of linked tracks that connect the mountain bike park base at the Trailer Park with a right of way beside Bethany Park.

The second stage consists of a higher elevation track that, by following contours, will cross several existing firebreaks, thus increasing riding options. It is scheduled for completion in 2010.

Most of the newly-benched trails are wide, easy to intermediate-grade tracks, complemented by narrower hand-benched single-track. Trading in Public Places Bylaw

This summary is made to fulfil the purposes of Sections 83(1)(a)(ii) and 89 of the Local Government Act 2002. The summary contains details of the changes proposed by the new Trading in Public Places Bylaw compared to that currently existing.

- A. These changes are as follows:
 - Removal of those activities in public places that are managed by other Council processes e.g. leases, licences to occupy, permitted activities under the TRMP, Food Hygiene Regulations requirements for Mobile Shops;
 - Inclusion of "Commercial Services" category for commercial services offered in a public place;
 - An attempt has been made to use simple language in the Bylaw and thus it has been substantially rewritten and reduced in size from the 2005 version, however the intent remains the same.

Taking of Bulk Water Supplies

The Tasman District Council Water Supply Bylaw 2009 came into effect on 1 January 2010. The Bylaw requires that only the New Zealand Fire Service can freely draw water from fire hydrants for the purpose of fighting fires, training and testing.

As from 1 January 2010 all users of bulk water from a Council network (potable water suppliers, contractors etc) are required to hold a current permit to take water. The annual permit fee is set at \$1000 (GST inclusive). Permit holders will also pay the current cubic metre rate for the water taken (\$1.17 m³ for the 2009/2010 financial year). All permits issued will expire annually on 30 June 2010. Permits issued prior to or after 1 July 2010 will have the annual permit fee pro-rated in line with the Schedule of Charges contained in Council's Ten Year Plan.

Anyone wanting to take bulk water from Council's supplies is required to complete an application form (available on Council's website).

Please note that contractors supplying potable water to the public are also required to complete the following:

- Register on the Ministry of Health's Register of Community Drinking- water Supplies and Suppliers.
- Comply with the requirements of Section 11, Drinking-water Standards for New Zealand 2005 (Revised 2008)
